Your ideas will shape the priorities of the Kumangka Warrarna Wangkanthi (Central) region to the State Voice.

Tell us your story, your concerns or your ideas to solve problems.

**Your Local Voice Members want to listen to you and be available as much as possible.**



You can talk with them when you see them around in your community or at a community event.



You might set up a day and time to have a one-on-one talk with your Local Voice member.



Members may arrange a community meeting with the support of the community.



Any feedback you give will be kept by Local Voice members. This is so it can be discussed and passed onto the State Voice to help inform their advice to the relevant decision makers.

Your Local First Nations Voice for the Kumangka Warrarna Wangkanthi (Central) region has been elected to speak up and reflect the views and priorities of the region.

Elected members have other responsibilities in their community, alongside their Voice role. This could be working full-time, caring for family members, studying, running a business or volunteering on boards and committees.

Voice members are committed to being active members in your region. They want to hear from you as they go about their responsibilities in the region.

# About the First Nations Voice

**South Australia's First Nations Voice to Parliament is made up of Aboriginal and Torres Strait Islander people from across the state, elected by you.**

There are 6 Local Voice regions and a State Voice representing South Australian Aboriginal and Torres Strait Islander communities.

The Voice is an advisory body only – this means it gives feedback and suggestions to the SA Parliament, government, and other decision-making bodies. It cannot make or stop laws, policies or, other decision-making processes.

The Voice can only comment on matters that relate to and impact Aboriginal and Torres Strait Islander people.

# About the Local Voices

Local Voice members have modest resources to meet everyone in their region - but are keen to meet as many people as they can.

They want to hear what community believes are the important matters in the region.

The Local Voices must meet at least 4 times a year (and a maximum of 6) to talk with each other about what they are hearing from you and the voices of community. They will share the community's views with the State Voice.
